



“Blazing Balls” Mystery Seat Promotion

Promotion Rules & Regulations

Participation in the “Blazing Balls” Mystery Seat Promotion (the “Promotion”) constitutes full and unconditional acceptance of these Official Rules and Regulations.

Promotion Overview

“Blazing Balls” is a Mystery Seat promotion in which eligible Encore Rewards members with their Encore Rewards card properly inserted at the time of the draw may be randomly selected to win Bonus Play prizes. Winners will be selected based on the ASL (Area Section Location) number of the slot machine being played at the time of the draw.

The winner of the Mystery Seat draw will be presented with the Casino of the Rockies “Blazing Balls” Mystery Seat Cart and will be asked to select a yellow ball from the “Blazing Balls” Display on the cart to be eligible to win a surprise amount of bonus play. Once the patron has selected a yellow ball, they will be asked to open the ball to reveal the number inside (1-5) that will correspond to a bonus play prize.

- Be an active Encore Rewards member; and
- Have their Encore Rewards card properly inserted into a slot machine at the time of the draw.
