Qualified Entry and Entrant

- A qualified entrant (Entrant) is a St. Eugene Golf Resort & Casino guest who is 19 years of age or older. Employees of the Casino of the Rockies and British Columbia Lottery Corporation (BCLC), as well as family and household members of the same who reside at the same address, are not eligible. Voluntary Self-excluded and Barred persons are not eligible to participate and will not be awarded a prize.

Ballot Prize Draw

- Gaming Promotions are offered in conjunction with BCLC.

- Patrons may place a minimum \$5 bet on a Proline Terminal at the Casino of the Rockies and bring their betting slip to the Casino Guest Services where they can then play Proline Plinko. Proline Plinko can be played once per day, to win a maximum of 5 ballots per daily play.
- Patrons participating in the Proline Plinko: World Cup Promotion will be eligible to receive a FIFA World Cup Pre-pack, distributed by Guest Services. Limit of one per patron, per day.
